The Honorable Judge Megan Goldish is our 2019 "Woman of the Year." Judge Goldish graduated with honors from the Northwestern Pritzker University School of Law. Prior to that, she received her undergraduate degree from the University of Illinois Urbana/ Champaign where she graduated *Magna Cum Laude* and as a Graduate of Distinction. Judge Goldish was elected to the bench in 2014 and currently sits in the Domestic Relations Division. Judge Goldish is extremely active in the legal community. She serves on the Board of Managers of the Decalogue Society of Lawyers and is the Second Vice-President of the North Suburban Bar Association. Judge Goldish is very involved in numerous charitable and civic activities. She serves as the co-President of the Chicago Lighthouse for the Blind Junior Board, is a Board member of the Lynn Sage Cancer Research Foundation as well as other Boards of charitable and civic organizations. Judge Goldish and her husband, Matthew Savage, a Chicago Police Crime Scene Investigator and a Major in the United State Army reside in Chicago.

Lieutenant Val Roytman and his family immigrated to the United States from Kiev, Ukraine in 1978. A graduate of Niles North High School, Lt. Roytman then attended the University of Illinois, Chicago, earning both a Bachelor of Arts and a Master of Arts degree(s). He was instrumental in developing the TARA2 program, a counter terrorism program for police officers. Lt. Roytman was promoted to lieutenant in September 2012 and assigned to the south and west sides. His last assignment was in the 17th (Albany Park) District. Lt. Roytman retired on June 15, 2019. He resides in Chicago with his wife, Anna. The Roytmans have a son and a daughter.

Lieutenant Gary Merrill is in his 24th year with the Cook County Sheriff's Office and is assigned to the Department Of Corrections. Prior to becoming a member of the Cook County Sheriff's Department in 1995 Gary was the Head Coach of the UICC-University of Illinois at Chicago Circle's Men's Intercollegiate Golf Team, and later worked in sales/ marketing management and training.
